

**Funds for Access 2018-2019 Financial Aid Information & Application  
EYO Addendum**

Members of the Etowah Youth Orchestras who are applying for financial aid through the Gadsden Cultural Arts Foundation’s Funds for Access Program for assistance with EYO financial obligations need to complete this addendum and submit it with the rest of the application packet. Applications for assistance with EYO financial obligations will not be considered complete without this addendum. This application is designed to cover any EYO program for which the student is applying. The following items will be considered through this application:

- Reduction or waiver of annual EYO membership fees
- Low-cost/no-cost instrument rental for participation in EYO programs
- The Bob Kintz Memorial Scholarship (for gentlemen in the EYO’s upper-level ensembles for tuxedo rental)

In maintaining the highest standards for the programs of the Etowah Youth Orchestras, the EYO has set forth the following minimum award obligations for recipients of financial assistance:

- Consistent attendance at ensemble rehearsals.
- Consistent practice and preparation for ensemble rehearsals.
- Positive evaluations from members of EYO instructional staff.
- Recipient must pay fees not covered by financial aid in full, and in a timely fashion.

Please note – if you feel that you will not qualify or do not need financial aid, but that a **payment program** will assist you with annual membership fees, please contact EYO Music Director Mike Gagliardo at [mikegagliardo@culturalarts.org](mailto:mikegagliardo@culturalarts.org) to make payment arrangements.

The EYO may request that this application be supplemented by additional written materials. Families applying for financial aid for multiple students in the program should complete an application for each student. Multiple students and multiple ensembles are taken into consideration when awarding financial aid. While applicants will be required to apply each season, preference for scholarship renewals will be given to returning students who have acceptable evaluation reports. Please note – at the time of application, all outstanding fees from the previous season(s) **MUST** be paid in full.
